### FORMATION OF SEPARATE TECHNICAL **AGENCIES (TAs)**

Following a joint review and consultation with the industry, PUB and NEA will operate as separate TAs with effect from 1st Jan 2017 with PUB focusing on water related matters and NEA focusing on environmental related matters. This is to improve our service to the building and construction industry and to provide a direct line of contact for our industry partners.

#### How will this affect you?

From 1 Jan 2017, separate building plan submissions will have to be made to NEA for pollution control and environmental health matters and to PUB for sewerage/sanitary and drainage matters separate clearances will be issued by PUB and NEA.

The Central Building Plan Department (CBPD) and Building Plan Unit (BPU) will also be serving as individual one-stop centres for NEA and PUB respectively. A new PUB mailbox will be created in CORENET for submissions to PUB. The changes are summarized in the table below.

#### Before 1 Jan 2017

- **ENVCBPU** mailbox
- Clearance(s) coordinated and issued by **NEA's CBPD**
- Only CBPD's clearance (issued before 1 Jan 2017) is required for the application to BCA for the final TOP/CSC clearance

#### From 1 Jan 2017

- Submissions to be made to A new PUB mailbox will be created in CORENET for submissions to PUB
  - For all SEW and DRA submissions and resubmissions, submit to the new PUB mailbox in CORENET
    - Clearances and Written Directions will be issued by the respective agencies (PC and EH matters from NEA and SEW and DRA matters from PUB)
    - If partial clearance is given on or before 31 Dec 2016, QPs are required to make resubmission (on areas that have not been given clearance) to the respective agencies for clearance).
    - Both CBPD and PUB's clearances are required (for clearance issued on and after 1 Jan 2017) prior to the application to BCA for the final TOP/CSC Clearance.

The new classification will be reflected in the revised PUB-BPU-CLRDP01 Form used for Detailed Plan Submissions.
